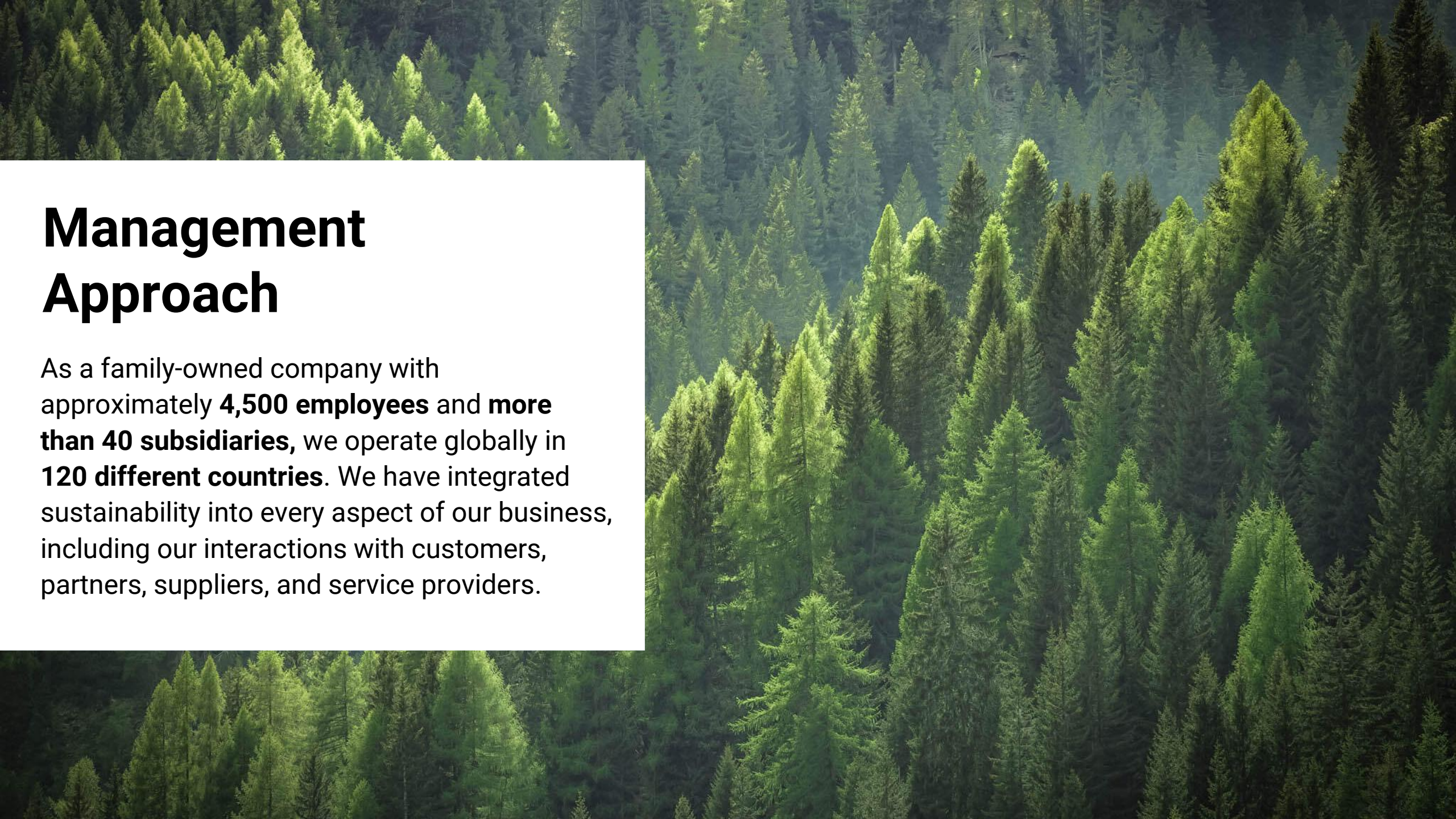

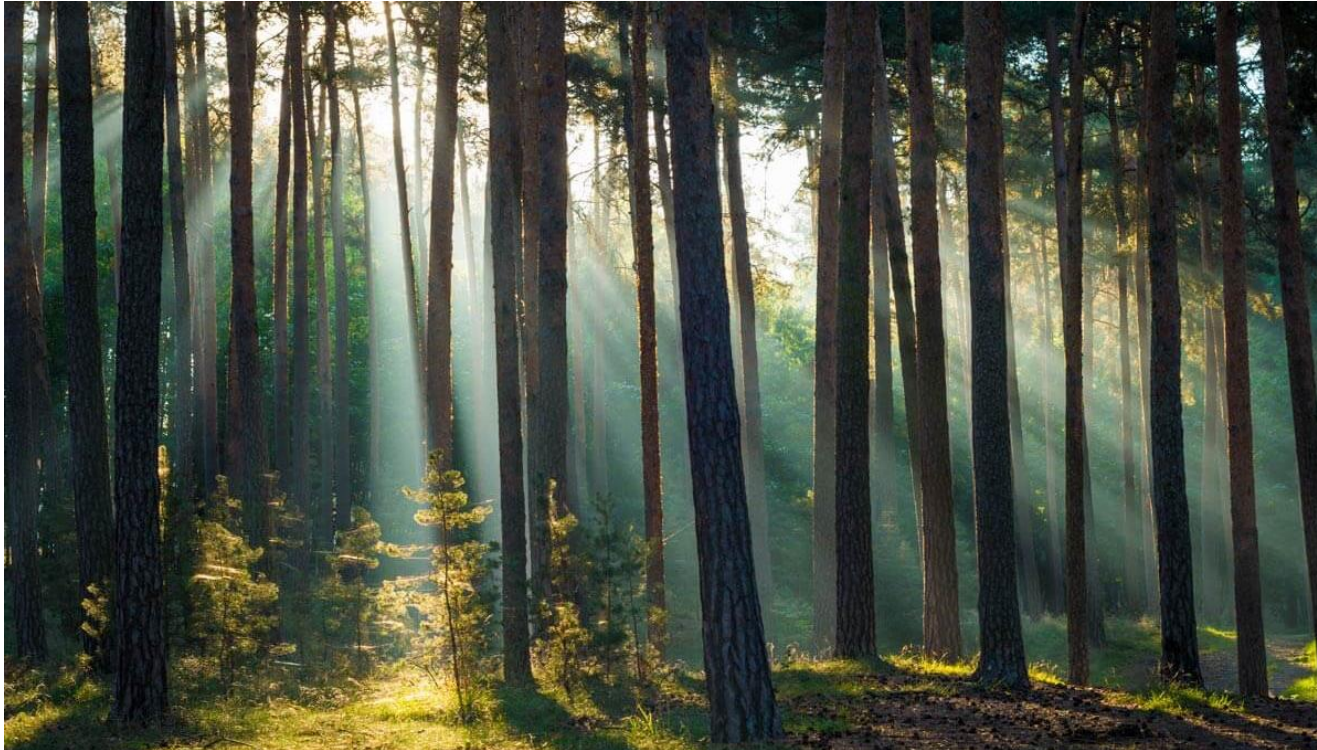


Management Approach

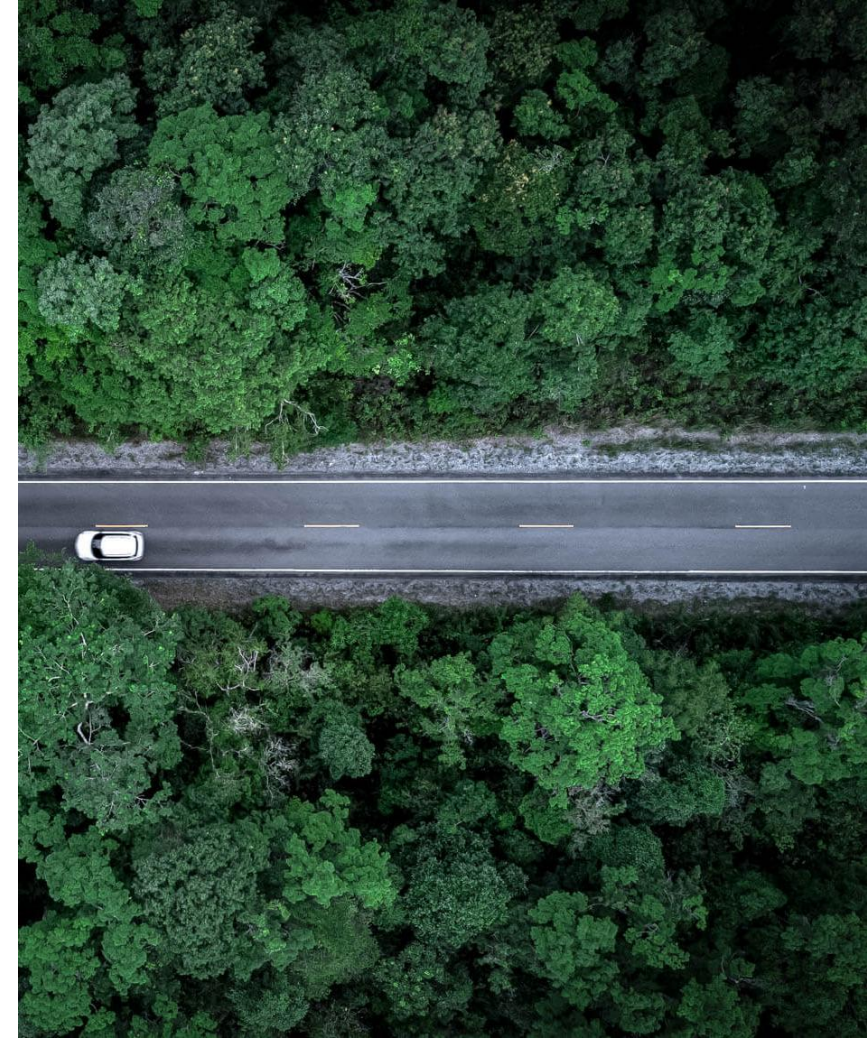
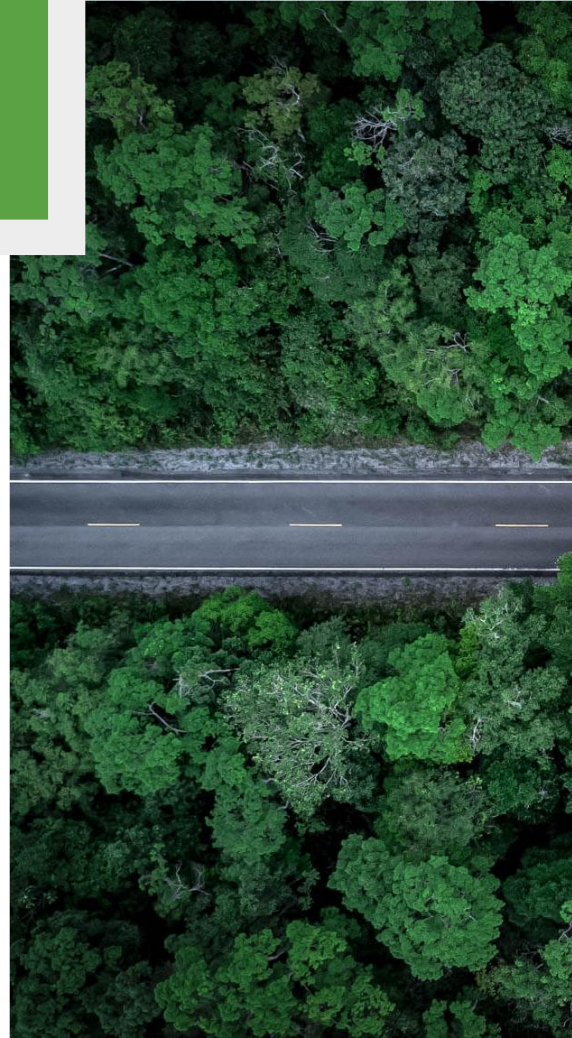

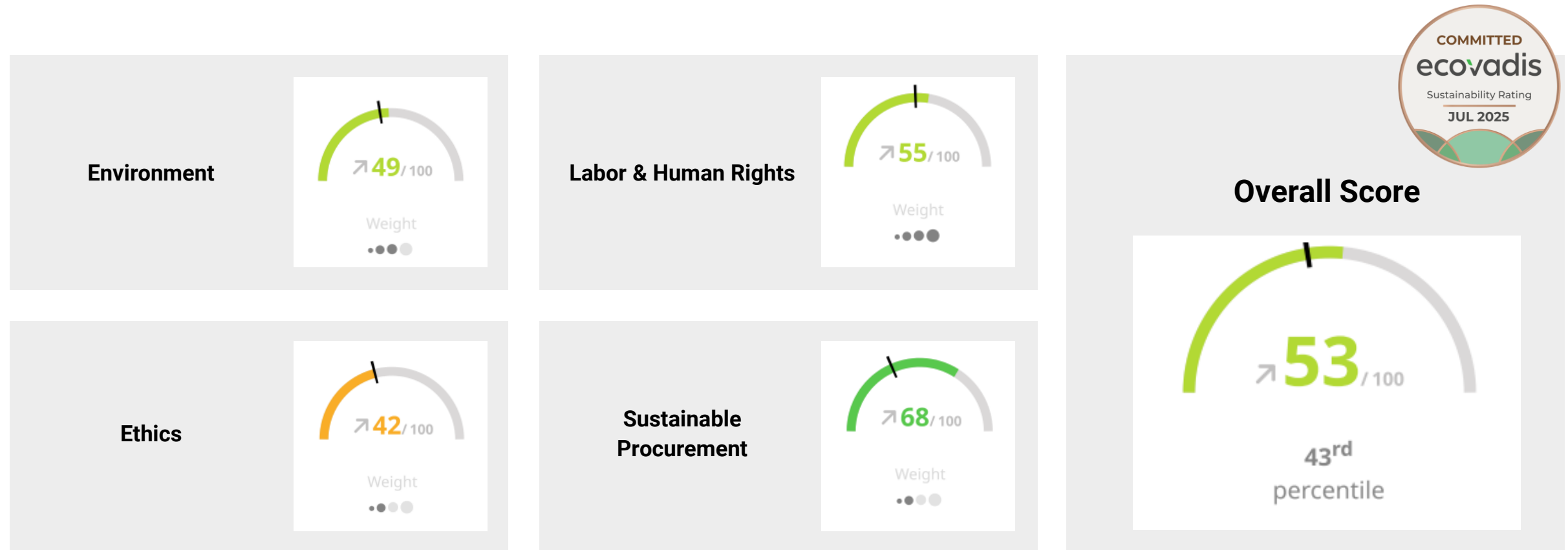

Our **Code of Conduct** provides an overview and affirms that our company maintains a positive and healthy work environment, with protection of our employees' personal data, and operates without discrimination or child labor. This document also guarantees the safety of our products and the integrity of market competition.



EcoVadis Scorecard

In the EcoVadis scorecard released on July 1, 2025, our company achieved an overall score of 53 - an **improvement of 11 points** compared to the previous assessment and received the Committed badge. This score remains valid until the same date in the following year, 2026. We are committed to enhancing our policies and strategies for a more sustainable business in the meantime.

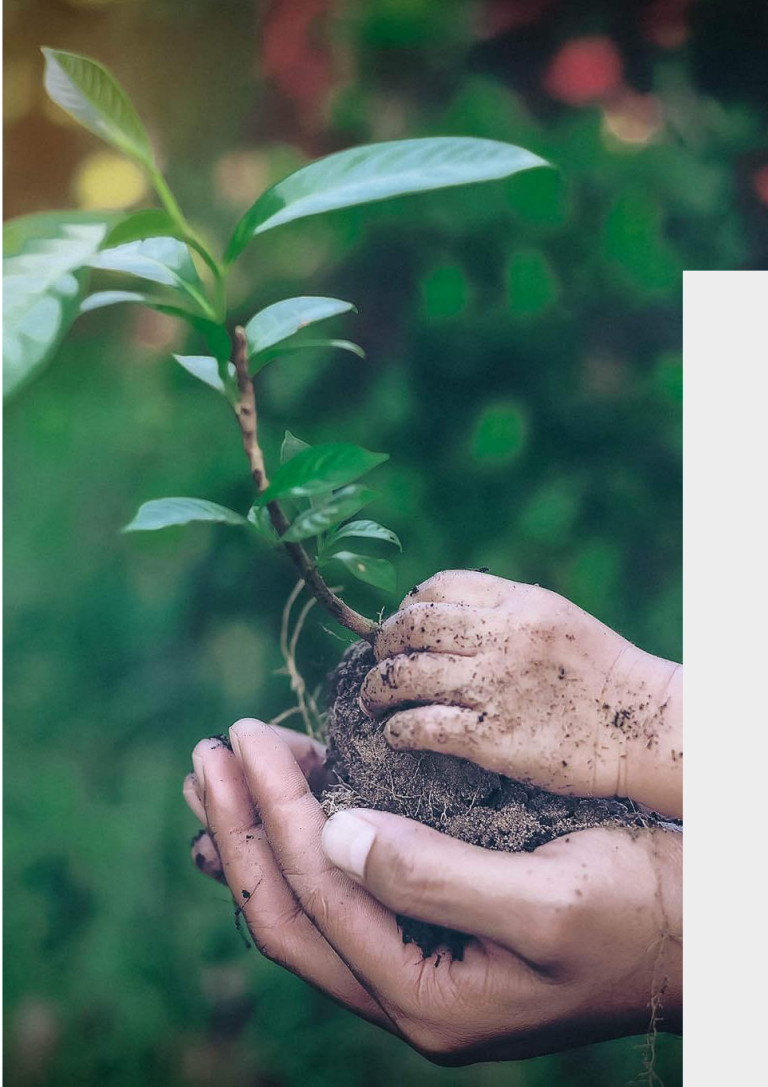
